Sub: Induction of suitable officers on deputation basis in to CBI

Sir,

CBI is looking for bright and competent officers from Income Tax Department having impeccable integrity for their induction as Inspectors of Police in Economic Offence Zone-I CBI, New Delhi. The initial period of deputation shall ordinarily not exceed 5 years, but the deputation period may be extended for a further period of 2 years. After the completion of their deputation tenure in CBI these officers will gain invaluable experience in investigation of Economic Offences and after their repatriation to their parent department and their services can be effectively utilized their departments.

As per the Recruitment Rules of CBI, the eligibility criteria for induction of Inspectors on deputation are as follows

1. Officers holding analogues post on regular basis in the parent cadre or department and with 5 year regular service in the grade of Inspector. (in the Pay Matrix of Level 8 of Pay corresponding to PB-2-9300-34800-Pre-revised grade)

2. Officer must possessing 05 years experience in Investigation/Vigilance/Intelligence.
 3. The officer must be a graduate from a recognized university

The officers joining on deputation in CBI are entitled to receive the following incentive packages.

- i. Special Security Allowance @ 20% of basic pay
- ii. Cash Compensation for working on Saturday / holiday @ 2 ½ days for every completed month of service subject to a maximum of 30 days in a year.
- iii. Medical facilities and Children Education Allowance as per the rules of the Central Government.
