(i) if after a review of the vacancies, it is found that his promotion is in excess of the vacancies available;

(ii) if found unfit for retention in the post of Tax Assistant.

c) The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No.1/1/2008 & DOPT O.M no. 13/02/2017-Estt(Pay-I), dated. 27.07.2017 regarding Exercising of option for fixation of pay on promotion.

- d) His/her seniority in the cadre of TAX ASSISTANT will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
 - e) His/her promotion is subject to outcome of recasting of reservation rosters in the cadre of tax assistant in accordance with i) DOP&T's O.M. No. 36012/45/2005-Estt (Res.) dated 10.08.2010 & ii) DOP&T's O.M. in F.No.36012/11/2016-Estt.(Res-I) (Pt-II), Dated. 15.06.2018.
3. Their promotion as Tax Assistant is subject to outcome of any Cases pending before the Hon'ble CAT and Hon'ble Courts.
 4. The official will not be eligible for pay fixation consequent to this promotion in case his pay has already been upgraded in the scale of Tax Assistant under ACP Scheme/MACP Scheme.
 5. The attention of the promoted officials may be invited to F.R. 22(1)(a)(1) regarding exercising of option for fixation of pay on promotion.
 6. The promotion order should be issued in the prescribed proforma immediately.
 7. Promotion to the cadre of Tax Assistant in respect of all the above mentioned officials are on *in-situ* basis. These Tax Assistants shall continue to discharge the same functions as MTS in their respective offices till further orders.
 8. This issues with the approval of the Pr. CCIT, Andhra Pradesh & Telangana.
