Sub: Establishment – I.T. Department, Andhra Pradesh & Telangana –
Promotion to the cadre of Income Tax Inspector – Allotment – Reg.

The following officials, whose names have been approved by the Departmental Promotion Committee for promotion to the cadre of **Income Tax Inspector** on **Regular basis** for panel year 2015-16 in the scale of Pay Band/Scale of PB-2 of Rs. 9300-34800 with corresponding Grade pay of Rs. 4600/- and such allowances as may be sanctioned from time to time, is allotted to the appointing authorities mentioned in column number 3 for being posted in the offices mentioned against their names at column number 4 of the table below:

The allotment posting made above is subject to review in ensuing Annual General Transfers.

2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:-
- His promotion is purely provisional;
 - He will be liable for reversion –
 - if after a review of the vacancies, it is found that his promotion is in excess of the vacancies available;
- Or
- if found unfit for retention in the post of Income Tax Inspector

- c) The attention of the promoted official is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No.1/1/2008 regarding Exercising of option for fixation of pay on promotion.
- d) His promotion and seniority in the cadre of Income Tax Inspector will be liable for revision at any point of time subject to seniority made in accordance with (i) O.A.No.598 of 2013 filed by Sri RSR Chandra Murthy and O.A.No.1325 of 2013 filed by Sri Manas Ranjan Behera filed before Hon'ble CAT (ii) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (iii) Out come of any other cases pending before the Hon'ble CAT/other Courts.
- e) Further, his seniority will also be liable for revision, if any bonafide mistake is found with reference to any records.
3. If the pay of the official has already been upgraded under ACP/MACP scheme, then he will not be eligible for pay fixation consequent to this promotion.
4. The promotion order should be issued in the prescribed proforma immediately.
5. This issues with the approval of the Pr. Chief Commissioner of Income Tax, Andhra Pradesh & Telangana.
