2. The following conditions should be mentioned the promotion order issued by the appointing authority:-

- a) Their promotion is purely provisional and;
- b) They will be liable for reversion –
- iii) If after review of the vacancies, it is found that their promotion is in excess of the vacancies available.

(Or)

- iv) If found unfit for retention in the post of Staff Car Driver, Grade-II.
- c) Their promotion as Staff Car Driver, Grade-II is subject to the outcome of any cases pending before the Hon'ble CAT and Hon'ble Courts.
- d) The attention of the promoted officials is invited to the MHA's O.M. F.No. 7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No. 01/01/2008 regarding exercising of option for fixation of pay on promotion.

- e) Their seniority in the cadre of Staff Car Driver, Grade-II will be liable to revision at any point of time, if any bonafide mistake is found with reference to any records.
- f) The officials will not be eligible for pay fixation consequent to this promotion in case of their pay has already been upgraded in the scale of Staff Car Driver under ACP/MACP Scheme.
- g) The above promotion to the cadre of Staff Car Driver, Gr-II is on in-situ basis.
