OFFICE ORDER

Objects of the Vivad Se Vishwas Scheme, 2020 are (a) reduction of income tax pending litigation (b) generation of timely revenues for the Government and (c) helping taxpayers end their tax disputes with the department by paying disputed tax and get waiver from payment of interest and penalty and immunity from prosecution as per terms of the DTVSV Act, 2020.

2. In order that the benefit of the Scheme reaches across to all eligible taxpayers, generate general awareness and resolve local issues related to the Scheme at the local level and flag other issues for resolution at an appropriate higher level, I am directed to convey approval of the Competent Authority for composition of DTVSV Local Coordination Committee (DTVSV LCC) comprising the following:

3. JCIT(Hq)(Tech), O/o the Pr.CCIT, AP&TS, [Email: hyderabad.addlcit.hq.tech@incometax.gov.in] shall be the Member Secretary (for extending secretarial assistance to the Committees including minuting proceedings of meetings and processing follow up on Committee's directions, suggestions and advice).

4. Terms of Reference of DTVSV LCC are below:

- (a) Resolve or coordinate or escalate for resolution any issues arising on taxpayers' references made to the Committee on any matter concerning the VSV applications made or to be made, in coordination with, wherever necessary, the concerned jurisdictional charges
- (b) Prepare the list of taxpayers' references on VSV filed with the Committee which require resolution at the Board/ Government level
- (c) Handhold and support the taxpayers in interpretation of VSV and its terms, and facilitate filing of declarations from interested taxpayers and to help facilitate issuance of certificates to the taxpayers under the Scheme
- (d) Any other matter related to DTVSV, 2020 as decided by the competent authority.

The Committee shall act only on references made by taxpayers or on requests for clarification made by jurisdictional Pr.CIT in respect of the referred scheme.

5. The Committee shall prepare progress reports of its activities and periodically or at such time it considers expedient, appraise the jurisdictional CCIT and Pr.CCIT of its activities through written reports. Tenure of the Committee is coterminous with the period up to which applications under the Scheme can be submitted.
