The Task Force shall call for and examine all the representations with regard to seniority issues and re-fix the same with a view to resolve the unsettled issues.

The Task Force is also empowered to co-opt any other officer/official as required for the above purpose.

The Task Force shall submit its report to the Pr. CCIT, AP & TS, Hyderabad by 11.10.2021. Further, it is directed that 1st meeting of the committee may be held on 21.09.2021.
