

Sub: Deputation of officers as Police Inspectors to CBI - reg.

CBI, Hyderabad intends to induct suitable officers to work as PIs on deputation basis from Central and State Police Organisations and also Income Tax, Central Excise and Railways. The CBI offers very challenging and professionally satisfying environment to PIs who would get an opportunity to investigate important cases of anti-corruption and other cases referred by the higher courts and Governments.

Eligibility criteria as per CBI recruitment Rules stipulate that the following officers are eligible for induction as Inspector in CBI :

(a) holding analogous post in State and Central Police Organisations on regular basis or with 5 years regular service in SI posts in the pay band-2 Rs.9,300-34,800 plus grade pay of Rs.4,200/- (prerevised) or equivalent .

(b) Possessing the educational qualification of graduate from a recognised university .

(c) Experience and three years experience in investigation of criminal cases.

(d) Inspector of Railway Protection Force or Inspector of Central Excise and Customs or Preventive Officers Grade.I or Examiner in Customs Office or Income Tax Inspectors or persons working in the analagous posts on regular basis under the Central Government or State Government or Central Public Undertaking .

The officers coming on deputation as Inspector in CBI are benefited with considerable increase in their monthly pay by way of SPECIAL INCENTIVE ALLOWANCE @ 20% of total of pay sanctioned by the Government to the Executive staff posted in CBI.

Period of deputation including period of deputation in another Ex-cadre post immediately preceding this appointment in the same or some other Organisation/ Deptt. of Central Govt. shall not exceed five years which may be extended for a further period of five years.

It is further intimated that the departmental officers in the feeder category which are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Simiarily, deputationists shall not be eligible for consideration for appointment by promotion. The maximum age limit for appointment by deputation/absorption shall not be exceeding 56 years as on the date of applications.

In this connection, it is requested that a panel of willing and suitable officers who can be spared immediately on their selection may kindly be sent to the Office of the Head of Branch , Central Bureau of Investigation Kendriya Sadan, Koti, Hyderabad in the prescribed proformat along with their bio -data duly signed by the applicant and countersigned by the sponsoring authority as per Annexure-I. It may kindly be ensured that complete C R dossier (either in original or attested true copies) along with integrity and vigilance clearance certificate of the applicants is invariably accompanied with the applications.
