It is to bring to your notice that in the current financial year 2018-19, the funds allocated were not utilized properly due to improper planning and incorrect projection of expenditure resulting in unutilized funds in some offices and excess utilization (more than allotment) in other offices. In order to avoid such a situation, it is proposed to assess the correct expenditure incurred/requisite budget for clearing the pending bills under various heads along with recurring expenditure for smooth running of the office. It may be noted that the bills that were not passed due to lack of funds, will be given top priority. The requirement of funds may be projected with sufficient details for undertaking the same.

2. In this connection, the DDOs are directed to submit the requisition of funds as per pro-forma enclosed before 1st of the every month so that it can be considered in the next allocation.
