Sub: Calling for willingness for posting of officers for E-verification Back Office / CPC for conducting pilots for E-verification in the Directorate of Income Tax (Systems), New Delhi - Regarding.

Under the E-assessment project, the Directorate of Income Tax (Systems) is planning to start Proof of Concept (PoC) of E-verification Back Office / CPC. The E-verification vertical will be headed by a PCIT/CIT level officer alongwith a complement of 4 Addl.DsIT/Jt.DsIT and 16 officers of the rank of DDIT/ADIT/ITO. The vertical will be based in Delhi/NCR.

2. Applications are invited from the officers of level of CIT, Addl.DIT / JDIT and DDIT / ADIT / ITO for posting in the Directorate of Income Tax (Systems), New Delhi. The applicant officers should fulfill the following conditions :-

- The officer should be willing to be posted in the Directorate of Systems (for a unspecified tenure not extending beyond three years).
- The officer should have understanding of working of Systems.
