Sub: - Furnishing of the list of sub-BCAs/DDO who are yet to be registered on GeMs in respect of all Budget Controlling Authorities (BCAs) - Regarding.

Kindly refer to the above cited subject.

2. This Directorate has circulated the guidelines of the Government of India in respect of the making arrangement for procurement of common use goods and services through GeM only. In one such observation No.OBS/1797 dated 12/-04/2017, Cabinet had made the following observation:-

'In order to realize the full potential of Government e- Market place (GeM), procurement of common use goods and services need to be made mandatory through GeM.'

3. This Directorate has also circulated a letter received from the office of Pr.CCA,CBBDT, N.Delhi vide its F. No. PCCA/CBBDT/PCS/zao-corros/16-17/3068-70 dated 01-01-2022 to all BCAs vide letter F. No. DIT(EB)/GFR/2021-22/1401 dated 19-01-2022. In this letter, the necessary steps to be followed for procurement of goods and services including manpower outsourcing and vehicles hiring was highlighted. It was communicated that as per the guidelines procurement has to be made through GeM.


4. Recently, this Directorate has received one RTI application through which the applicant has raised various queries with regard to Government e-Markets Plus (GeM). One query is with regard to the number of DDOs not yet on board on GeMs so far. As the information in this regard was readily not available with this Directorate, so the applicant was informed accordingly.

5. With reference to this, this Directorate is seeking information from all the BCAs. Accordingly, if there is any DDO under your charge who is not yet registered on GeMs so far, the details of the same along with the reason may kindly be provided to this Directorate. In case, all the DDOs of your charge have been registered on GeM, a certificate to this effect may be given. As the information is required for an RTI matter, the response may be given at the earliest considering the time bound nature of the same.
